Requested increase in presence on Rec Ground following fire at S/C Infants School. Discussion regarding traffic enforcement as per issues raised at previous Council meeting. Police cannot enforce yellow line offences but can get vehicles removed if causing obstruction and can enforce on pedestrian crossings. Will speak to drivers causing obstructions need to report on 101 or by online reporting.

Issues re parking on Birchwood Lane – take down VRN's and report to Police, who will speak to offenders. Can check if vehicle taxed by checking on DVLA.

Air rifle being fired through hedge at Birchwood Lane Allotments, will report to PCSO R Plant for observations.
