79/2011: Car Park Agreements: The draft agreements have been completed and now with our solicitors. A meeting is to be held with our solicitors and a report made to the Council. AVBC have agreed to repair the potholes at the entrance of the Market Place car park prior to the completion of the agreements for transfer.

80/2011: Options for Housing Growth: Consultation July – September 2011

The maps provided by AVBC (to be available at PC Meeting) indicate the areas for development, including 'greenbelt land', for housing and business. Additional area maps have been supplied for Somercotes - **Appendix 'B'**

The vacancy for co-option of a Councillor has been advertised, as agreed by the Council, and there is one applicant.

83/2011: Winter Planting of flower beds at Parish Hall & Winding Wheel:

AVBC will no longer carry out the planting of the flower beds (free) in front the Parish Hall & Winding Wheel so quotes for the work have been obtained – **Appendix 'D'**

For discussion and decision by the Council

84/2011: Clerk's Report

a) War Memorial Cleaning: The new company has yet to respond with a cost of annual cleaning.

- b) Pye Bridge Waste Incineration Plant: The licence for the incinerator plant has been approved by the Environment Agency and the application is now going through the planning committee process.
- c) Hockley Way Pedestrian Central Refuge Proposal: DCC have been informed of the cost match by Somercotes Parish Council to complete the work. Alfreton Town Council is considering if it will financially support the project.
- d) **New Recreational Facility Somercotes Park:** The new sport and fitness activity equipment has now been installed on the recreation ground.
- e) **AVSSP:** The first half of the grant (£500.00) has been issued to AVSSP and letters sent to the schools requesting support for sport & physical activities.
- f) **New Heating Boilers installed:** The two new gas boilers (2 year warranty) have been installed at a cost of £3,880.00
- g) Newsletter: Sub-Committee meeting: It has been proposed to have a 6 month trial using Facebook for advertising the Parish Hall. Calendar Competition: Council to decide on if a calendar is to be produced as no photographs have been received.

Recommend not to print a calendar due to time constraints for printing and selling.

For Council Consideration and decision

- h) **Pennytown Ponds Award:** The Council is pleased to announce the National Green Flag Award attained in July 2011.
- i) **Power of Well-Being:** The Council is required to have 80% of members to be trained and a CiLCA qualified administrator to implement the Power of Well-Being (may well be changing in the next 12 months). If the Power of Well-Being is implemented then S137 is suspended during the period of the project normally 1 or 2 years.
- j) Carol Service: The Carol Service has been arranged for Friday, 9th December 2011
- k) Allotments
 - Bridle Lane: Only a few tenancy agreements still outstanding. Proposals for large Ash tree reduction in size and removing of dead branches.
 - Birchwood Lane: Tenancy agreements still outstanding
 - Flash Allotments: The members have formed a committee and have commenced work on reclamation of the land to bring a number of allotments back into use.
 - Drunken Close: There has been a breach of the lease by one tenant keeping more than the 3 horses/ponies on the land. A notice of eviction was served after repeated letters for compliance. The tenant has now met with the Clerk and reduced the number of animals and paid the outstanding balance of the rent.

For Council decision – on whether to enforce or withdraw the notice based on future compliance by the tenant.

- l) **CCTV** New monitor required and installed cost £50.00
- m) Lease of the Parish Hall: The lease agreement has been located and the content viewed. The lease agreement states that the Parish Council shall pay £5 per annum and no payments have been made since the signing in 1995. The Council has made the back payments of £80.00.
- Staff Appraisals: A draft of the Staff appraisal system has been prepared. It is important that all staff receive an appraisal to ascertain if they have any problems, issues or training needs.

- **0)** Enforcement Report Shady Farm: For Information Appendix 'E'. This is not for Council involvement and is for information only.
- 0) **Photo-Copier Contract:** The 5 year lease agreement is due for renewal on 1st January 2012 and three quotes have been obtained. The quotes and cost is attached at **Appendix 'F'**

It is recommended, based on the quotes provided, to continue with Rioch on a 5 year lease for a new copier. Leasing includes toners, training and servicing.

- p) **Poops Scoop Bags update:** The Council purchased 100,000 poop scoop bags in March 2011 and for the first 6 months around 50,000 have been used.
