- Somercotes would be amalgamated with Alfreton
- Pye Bridge would be amalgamated with Riddings, Ironville and Swanwick

The Parish Council was not made aware of the proposals under the Parliamentary Constituency Consultation (ends on the 6<sup>th</sup> December 2011), at the last Parish Council Meeting.
