- (c) Cllr Smith (DCC) reported that DCC had been dealing with flooding in the area. Anyone requiring emergency assistance should contact Call Derbyshire or 101. Reorganisation in DCC had resulted in Rights of Way Team moving to the Highways Department. There would be a reduction in Library opening hours. No further information had been received regarding Youth Clubs. Request that the Clerk contact DCC to relay concerns regarding the junction of Quarry Road and request information on monitoring frequency. Request that the availability of sandbags be circulated to residents with details of after hours access.

(d) Cllr Lyttle (AVBC) stated that the site meeting by Planning officers to Stanley Street had taken place and the application would be considered at a future meeting. AVBC had resolved to hold full elections every four years. Tree planting will be approved in December and the trees circulated in the New Year. Request that the Clerk contacted AVBC regarding the planning application for the old Vyella site which originally had provision for development of football pitch/green space. Cllr McCabe(AVBC) stated that the Planning Application at Parkside required access to road network and would be required to provide 30% affordable housing and S106 monies to upgrade footpath and recreation ground. Cllr McCabe requested that the Clerk made enquiries to establish prices for a flag pole and report to next meeting.
