4/2021: Public Speaking:

- (a) The Clerk read out an email received from the police:
  - Last year residents on Somercotes Hill were spoken to and leafletted regarding parking on the pavements.
  - The Police will be speaking to Highways about repainting the solid white line system into Pye Bridge
  - The anti-social use of the Car Park at the business park on Nottingham Road (The Range/Aldi) is being addressed. The police liaised with AVBC regarding this and they have been in contact with the land owners. They have intimated that they will erect barrier gates and the Council are in the process of chasing progress. The police are able to issue warnings to drivers who are using the car park in an antisocial way and have done so in the past. It is important, if people are contacting the police, that they have vehicle details and can give us evidence of the manner of driving.
  - The Police are happy to educate vehicle owners in the first instance regarding the use of their vehicle so please give my details and they can contact PC Shurki to progress any worries.
- (b) Derbyshire County Council Cllr Smith:
  - Likely that a meal vouchers scheme for schoolchildren would be adopted.
  - A Test & Trace facility was scheduled for Cotes Park Industrial Estate
  - The HWRC at Loscoe and libraries were operating a click and collect system.
