30/2023.24: Public Speaking - (30 Minutes)

A number of members of the public spoke about issues on the development site on Stanley Street. Those issues included noise, dust, deterioration of pavements, and heavy vehicles travelling to the site. The issue of parking was also raised with concerns expressed about a possible three year parking ban on Stanley Street which could be under consideration by the Highways Authority. There were also issues that service vehicles such as refuse lorries were unable to gain access to empty bins.

Councillors updated members of the public on correspondence they had received relating to these and other related issues.

Council **RESOLVED**:

(a)That the clerk write to the Chief Constable to raise the issue of heavy vehicles on Stanley Street and to bring to his attention that they were mounting the pavements in order to gain access to the building site

(b)That the clerk write to the cabinet member for Highways regarding the deterioration of pavements on the street and the consequential difficulties this presented for disabled residents.
